**NCI-SRD JOINT RESOLUTION NO. 07 Series of 2020**

**APPROVING THE NCI-SRD STRATEGY FRAMEWORK AS BASIS FOR THE ESTABLISHMENT  
OF THE NCI-SRD RESULTS-BASED MONITORING AND EVALUATION (RBME) SYSTEM**

**WHEREAS**, the Philippine Development Plan (PDP) 2017-2022 states that, “in order to strengthen the efficiency and effectiveness of environmental and governance strategies, the government will continue to pursue the national convergence initiative using the ridge-to-reef approach”;

**WHEREAS**, the DA-DAR-DENR-DILG NCI-SRD Joint Administrative Order (JAO) No. 1, series of 2020 (Revised DA-DAR-DENR-DILG JAO No. 01, Series of 2015: Strengthening the Implementation Framework for the DA-DAR-DENR-DILG NCI-SRD) took effect last 21 May 2020 which covers the mechanisms and operationalization of the NCI-SRD strategy from the national to the municipal/city levels where the NCI-SRD strategy is implemented;

**WHEREAS**, Section 9 (Results-Based Monitoring and Evaluation) of the DA-DAR-DENR-DILG NCI-SRD JAO No. 1, series of 2020 states that “a RBME system based on indicators of performance aligned with the PDP Results Matrix shall be developed, implemented and managed”;

**WHEREAS**, DA-DAR-DENR-DILG NCI-SRD JAO No. 01, series of 2020 states that the Knowledge Management Component Working Group (KM CWG) shall be responsible for the development and management of the NCI-SRD information system, which covers the Results-Based Monitoring and Evaluation (RBME) system;


**WHEREAS**, the KM CWG convened in a regular meeting held on 03 April 2019 to discuss the draft NCI-SRD Strategy Framework and agreed to form a monitoring and evaluation (M&E) subgroup;

**WHEREAS**, the KM CWG M&E subgroup convened in a special meeting held on 01 October 2019 to discuss the draft NCI-SRD Strategy Framework;

**WHEREAS**, the KM CWG and Regional Convergence Initiative Technical Working Group (RCI TWG) Eastern Visayas reviewed the draft NCI-SRD strategy framework during the year-end assessment and operational planning held on 05 to 08 November 2019 in Javier, Leyte;

**WHEREAS**, the KM CWG in its regular meeting held on 05 March 2020 agreed to endorse the final NCI-SRD Strategy Framework (attached as **Annex A**) indicating the strategy objective, strategic approach and key results areas for final technical review of the NTWG, to wit:

1. Strategy objective: ***“Improved governance and optimized use of resources for the achievement of AFF sector goal”***

2. Strategic approach: ***“Complementation and mainstream efforts and resources (planning, budgeting, implementation, and monitoring and evaluation) of NCI-SRD agencies (DA-DAR-DENR-DILG) and other stakeholders that focused on the smallholder farmers (both agrarian reform beneficiaries or ARBs and non-ARBs), small fisherfolk, upland dwellers, and Indigenous Peoples (IPs) at the convergence area in strengthening LGUs to grow sustainable local economies”***
3. Key result areas: ***(1) enhanced institutional efficiencies, (2) expanded opportunities for Agriculture, Forestry, and Fisheries (AFF)-enterprise development, and (3) improved spatial integration.”***

**WHEREAS**, the National Technical Working Group (NTWG), composed of the Chairpersons of the four (4) CWGs, convened in a regular meeting held on 02 June 2020 and agreed to endorse the NCI-SRD Strategy Framework to the NSC for approval after its final technical review;


**WHEREAS**, the NSC, composed of the Permanent Alternate DA-DAR-DENR-DILG Undersecretaries, convened in a regular meeting held on 30 June 2020 and approved the NCI-SRD strategy framework of the KM CWG;

**NOW, THEREFORE**, for and in view of the foregoing, we, the NSC hereby RESOLVES to adopt and approve the NCI-SRD Strategy Framework. It further resolves to direct the KM CWG, in coordination with the Policy and Advocacy (PA), Agriculture, Forestry, and Fishery Enterprise Cluster and Business Development (AFFECBD), Capacity Development (CD) CWGs, Regional Convergence Initiative (RCI) TWGs, and other relevant stakeholders to establish a NCI-SRD RBME system based on the NCI-SRD strategy framework.
