# DIRECTING THE REGIONAL CONVERGENCE INITIATIVE TECHNICAL WORKING GROUP (RCI TWG) CENTRAL VISAYAS TO PROCEED WITH PREPARATION AND FORMULATION OF THE CONVERGENCE AREA DEVELOPMENT PLAN (CADP) OF BADIAN-ALEGRIA-DALAGUETE-ALCOY-MALABUYOC (BADAM) WATERSHED IN CEBU

WHEREAS, the DA-DAR-DENR-DILG Joint Administrative Order (JAO) No. 1, series of 2020 (Revised DA-DAR-DENR-DILG IAO No. 01, Series of 2015: Strengthening the Implementation Framework of the DA-DAR-DENR-DILG NCI-SRD) took effect last 21 May 2020 which provides the legal basis for the NCI-SRD operations and strengthen its implementation;

WHEREAS, the DA-DAR-DENR-DILG IAO No.1, series of 2020 states that the Regional Convergence Initiative Technical Working Group (RCI TWG) shall act as the regional arm of the National Technical Working (NTWG) in supervising the implementation of the programs, activities, and projects (P/A/Ps) under the approved Convergence Area Development Plan (CADP) and the NCI-SRD;

WHEREAS, the NCI-SRD Joint Resolution No. 03, series of 2018 was issued on 12 January 2018, adopting the "One Convergence Area per Region" Policy;

WHEREAS, the NCI-SRD Manual of Operations (approved under NCI-SRD Joint Resolution No. 07, series of 2018) underscored the importance of the CADP as a comprehensive plan which addresses the management of the watershed and the ecosystem in a holistic and sustainable manner through complementation of efforts and resources from the NCI-SRD member agencies, the Local Government Units (LGUs), and all relevant stakeholders involved;

WHEREAS, the RCI TWG Central Visayas issued Resolution No. 01 Series of 2019 on 24 September 2019, approving the proposal to adopt the Badian-Alegria-Dalaguete-Alcoy-Malabuyog (BADAM) watershed in Cebu as the RCI-SRD 7 watershed convergence of Cebu province, based on request of the local government units to continue with the previous initial plans to create a BADAM watershed convergence;

WHEREAS, the National Technical Working Group (NTWG), composed of the Chairpersons of the CWGs and ETWGs, convened in a regular meeting held on 02 June 2020 and agreed to endorse the BADAM watershed as a new convergence area of RCI TWG Central Visayas to the National Steering Committee (NSC), after its final technical review of the convergence area briefer;
