DIRECTING THE REGIONAL CONVERGENCE INITIATIVE TECHNICAL WORKING GROUPS (RCI TWGs) TO ADOPT THE NCI-SRD MANAGEMENT INFORMATION SYSTEM (MIS) AS PART OF THE NCI-SRD RESULTS-BASED MONITORING AND EVALUATION (RBME) SYSTEM

WHEREAS, the Philippine Development Plan (PDP) 2017-2022 directs the government to complement strategic efforts with environmental and governance strategies through the national convergence initiative using the ridge-to-reef approach and the sustainable integrated area development (SIAD) for the sustainable management of natural resources and rural development;

WHEREAS, the NCI-SRD is a strategy to develop and operationalize a common framework for Sustainable Rural Development that will facilitate the convergence and the monitoring and evaluation of the resources of the different agencies;

WHEREAS, the DA-DAR-DENR-DILG JAO No. 1, series of 2020 states that the Regional Convergence Initiative Technical Working Group (RCI TWG) shall act as the regional arm of the National Technical Working (NTWG) in supervising the implementation and monitoring and evaluation of the programs, activities, and projects (P/A/Ps) under the approved Convergence Area Development Plan (CADP) and the NCI-SRD;


WHEREAS, the Alternate National Steering Committee (ANSC), through NCI-SRD Joint Resolution No. 12 series of 2018, approved the NCI-SRD National Capacity Development Plan which includes the establishment of a management information system by 2021;

WHEREAS, the NCI SRD Knowledge Management Component Working Group (KM CWG), in its FY 2019 Year-End Assessment and FY 2021 Operational Planning, approved the proposed plans and activities, features and functionalities, database structure and design, data reporting flow chart, and timelines for the NCI-SRD MIS;

WHEREAS, the National Steering Committee (NSC), through NCI-SRD Joint Resolution No. 07 series of 2020, approved the NCI-SRD Strategy Framework as basis for the establishment of the NCI-SRD RBME system;

WHEREAS, the KM CWG and RCI TWG participated in the orientation and pilot-testing of the NCI-SRD MIS on 17 to 18 June 2020;

WHEREAS, the NCI-SRD MIS User Acceptance Testing was conducted on 18 to 20 August 2020 to present the revised draft MIS to the KM CWG and RCI TWG;
