IV. **NCI-SRD National Secretariat Major Accomplishments**

The National Secretariat functions as the main coordinating body of the NCI-SRD. It coordinates and facilitates the conduct of the NSC and NTWG meetings, workshops, writeshops, seminars, fora, consultations, among others. It is mandated to submit monitoring and progress reports to the NSC, NTWG, and other oversight bodies, and assists in the consolidation of the operational budget.

In 2021, the National Secretariat was able to hold six (6) regular meetings per Component Working Group, four (4) regular meetings of the National Technical Working Group (NTWG), four (4) regular meetings of the National Steering Committee (NSC) and one (1) NSC Special Meeting cum Writeshop.

Throughout the year, it was able to hold 44 regular staff meetings which are done weekly, 21 fortnightly reports. Apart from this, it regularly attends the general assembly meeting hosted by the DA Office of the Undersecretary for Special Concerns and Permanent Alternate Chairperson of the NSC where weekly progress reports are presented.

With the assistance of the National Secretariat, thru the lead coordinators per Component Working Groups, it was able to successfully facilitate the following activities and/or output:
