NCI-SRD RESOLUTION NO. 4 series of 2022

DIRECTING THE NCI-SRD COMPONENT WORKING GROUPS (CWGs) AND THE REGIONAL CONVERGENCE INITIATIVE TECHNICAL WORKING GROUPS (RCI TWGs) TO ADOPT THE NCI-SRD RESULTS-BASED MONITORING AND EVALUATION (RBME) THEORY OF CHANGE MODEL AND RESULTS INDICATORS

WHEREAS, the Philippine Development Plan (PDP) 2017-2022 directs the government to complement strategic efforts with environmental and governance strategies through the national convergence initiative using the ridge-to-reef approach and the sustainable integrated area development (SIAD) for the sustainable management of natural resources and rural development;

WHEREAS, the NCI-SRD is a strategy to develop and operationalize a common framework for Sustainable Rural Development that will facilitate the convergence and the monitoring and evaluation of the resources of the different agencies;

WHEREAS, the DA-DAR-DENR-DILG JAO No. 1, series of 2020 states that the Regional Convergence Initiative Technical Working Group (RCI TWG) shall act as the regional arm of the National Technical Working (NTWG) in supervising the implementation and monitoring and evaluation of the programs, activities, and projects (P/A/Ps) under the approved Convergence Area Development Plan (CADP) and the NCI-SRD;

WHEREAS, the National Steering Committee (NSC), through NCI-SRD Joint Resolution No. 7, series of 2020, approved the NCI-SRD Strategy Framework as the basis for the establishment of the NCI-SRD RBME System;

WHEREAS, the NCI-SRD Knowledge Management Component Working Group (KM CWG), conducted an RBME Writeshop on 23 to 26 March 2021 to increase the technical knowledge and skills in developing an RBME System;

WHEREAS, the NCI-SRD KM CWG, in its 5th meeting on September 29, 2021, approved the final draft RBME Theory of Change Model and results indicators, and recommended that the CWGs and RCI TWGs utilize them as the basis for the impact evaluation of the NCI-SRD strategy and in monitoring and evaluation of the convergence areas;

WHEREAS, the NTWG, KM CWG, and RCI TWGs participated in the RBME Consultative Workshop on 10 to 12 November 2021 and agreed to endorse the recommendation of the KM CWG for the CWGs and RCI TWGs to utilize the RBME Theory of Change Model and results

WHEREAS, the NTWG and NSC during their special meeting on 9 December 2021, agreed to endorse the final revised draft of the NCI-SRD RBME Theory of Change Model and results indicators for the adoption of the CWGs and RCI TWGs as the basis for impact evaluation of the NCI-SRD strategy and in monitoring and evaluation of the convergence areas;

NOW, THEREFORE, for and in view of the foregoing, the NSC hereby RESOLVES to direct the CWGs and RCI TWGs to adopt the NCI-SRD RBME Theory of Change Model and results indicators as the basis for impact evaluation of the NCI-SRD strategy and in monitoring and evaluation of the convergence areas.
