NCI-SRD RESOLUTION NO.18 Series of 2018

INCLUSION OF NCI-SRD ACTIVITIES IN THE INDIVIDUAL PERFORMANCE COMMITMENT AND REVIEW (IPCR) AND DIVISION PCR (DPCR) AND OFFICE PCR (OPCR) OF NCI-SRD NATIONAL AND REGIONAL MEMBERS

WHEREAS, Joint Administrative Order (JAO) No. 1 Series of 2015 stipulates that the Policy and Advocacy Component Working Group (PA CWG) "is responsible for the review and audit of conflicting and overlapping laws, policies and programs that hamper the implementation of programs and projects of the different agencies and shall recommend and draft relevant policies and other issuances that would harmonize or improve existing policies;"

WHEREAS, the issue of lack of permanent regular representation to the National Technical Working Group (NTWG), CWGs, Ecosystem TWGs (ETWGs) and Regional Convergence Initiative (RCI) TWGs was raised during the NCI-SRD Mid-Year Assessment and Operational Planning held last 21 to 22 June 2017 in Bago Bantay, Ilocos Sur;

WHEREAS, the PA CWG proposed to include NCI-SRD activities in the IPCR, DPCR and OPCR of member agencies in order to sustain the active engagement of NCI-SRD representatives and address lack of regular representations to the different TWGs, CWGs and ETWGs during the NCI-SRD Capacity Building Needs Assessment Workshop held last 03 to 06 April 2018 in Subic, Zambales;

WHEREAS, the PA CWG identified the drafting of a joint NCI-SRD resolution to include the NCI-SRD activities in the IPCR/DPCR/OPCR of NCI-SRD members as one of the priority capacity building activities for FY 2018 in the final draft NCI-SRD National Capacity Development Plan for FY 2018-2022;

WHEREAS, the NCI-SRD NTWG, composed of the Chairs of the CWGs and ETWGs, agreed to endorse the final draft NCI-SRD National Capacity Development Plan for FY 2018-2022 to the NCI-SRD Alternate National Steering Committee (ANSC) for approval, including the drafting of the abovementioned resolution, during its regular meeting held last 06 July 2018 at the BSWM, Visayas Avenue, Quezon City;

WHEREAS, the NCI-SRD ANSC, composed of the Undersecretaries of the DA, DAR, DENR and DILG, approved the NCI-SRD National Capacity Development Plan for FY 2018-2022, including the drafting of the abovementioned resolution, during its meeting held last 27 July 2018 at the Department of Agriculture, Elliptical Road, Diliman, Quezon City and approved;

WHEREAS, the NCI-SRD NTWG, convened in a regular meeting last 26 September 2018 and agreed to endorse the joint NCI-SRD resolution to include the NCI-SRD activities in the IPCR/DPCR/OPCR of NCI-SRD members to the ANSC;
