**NCI-SRD RESOLUTION NO. 17 Series of 2018**

**DIRECTING THE REGIONAL CONVERGENCE INITIATIVE TECHNICAL WORKING GROUP (RCI TWG) NORTHERN MINDANAO TO FUND AND IMPLEMENT THE MT. BALATUCAN RANGE CLUSTER OF MISAMIS ORIENTAL AND MT. INAYAWAN-ILLANA AND ROYAL CLUSTERS OF LANA DEL NORTE CONVERGENCE AREA DEVELOPMENT PLANS (CADPs) FOR FY 2019-2023**

**WHEREAS**, the NCI-SRD National Steering Committee (NSC), composed of the Department Secretaries of DA, DAR, DENR and DILG, issued the NCI-SRD Resolution No.1 Series of 2016 last 14 November 2016, adopting the DA-DAR-DENR-DILG JAO No.1 Series of 2015 (Strengthening the Implementation Framework of the NCI-SRD) under the Duterte Administration;

**WHEREAS**, the DA-DAR-DENR-DILG JAO No.1 Series of 2015 states that the Regional Convergence Initiative Technical Working Group (RCI TWG) shall manage and supervise the programs, projects, and other related activities at the regional level and shall act as the regional arm of the NCI-SRD Ecosystem Technical Working Groups (ETWGs) and NCI-SRD Component Working Groups (CWGs) in carrying out their functions;

**WHEREAS**, the NCI-SRD Convergence Area Development Plan (CADP) Manual of Operations underscored the importance of the CADP as a comprehensive plan which addresses the management of the watershed and the ecosystem in a holistic and sustainable manner through synchronization of inputs from the member agencies, the Local Government Units (LGUs), and all relevant institutions involved;

**WHEREAS**, the RCI TWG Northern Mindanao conducted the CADP Workshop for the three (3) clusters last 18 to 22 April 2016;

**WHEREAS**, the NCI-SRD Resolution No. 03 Series of 2018 was issued last 12 January 2018, adopting the "One Convergence Area per Region" Policy;

**WHEREAS**, the RCI TWG Northern Mindanao endorsed the final CADPs of Mt. Balatucan Range Cluster of Misamis Oriental and Mt. Inayawan-Illana and Royal Clusters of Lanao del Norte last 11 September 2018 to the Alternate National Steering Committee (ANSC) for approval;

**WHEREAS**, the NCI-SRD National Technical Working Group (NTWG), composed of the Chairs of the CWGs and ETWGs, convened in a regular meeting last 26 September 2018 and agreed to defer the endorsement of the CADPs of Mt. Balatucan Range Cluster in Misamis Oriental and Mt. Inayawan-Illana and Royal Clusters in Lanao del Norte to the NCI-SRD ANSC for approval, subject to the presentation of the RCI TWG Northern Mindanao;

WHEREAS, the NCI-SRD NTWG convened in a special meeting last 15 October 2018 and agreed to endorse the CADPs of Mt. Balatucan Range Cluster in Misamis Oriental and Mt. Inayawan-Illana and Royal Clusters in Lanao del Norte to the NCI-SRD ANSC for approval of the NCI-SRD Alternate National Steering Committee (ANSC), after its final technical review with the RCI TWG Northern Mindanao;

WHEREAS, the NCI-SRD ANSC, composed of the Undersecretaries of the DA, DAR, DENR and DILG, convened in a special meeting last 19 October 2018 and approved the CADPs of Mt. Balatucan Range Cluster in Misamis Oriental and Mt. Inayawan-Illana and Royal Clusters in Lanao del Norte;

NOW, THEREFORE, for and in view of the foregoing, we, the NSC, hereby RESOLVES to direct the RCI TWG Northern Mindanao to fund and implement the CADPs of Mt. Balatucan Range Cluster in Misamis Oriental and Mt. Inayawan-Illana and Royal Clusters in Lanao del Norte to commence in FY 2019 until 2023.


