APPROVING THE DA-DAR-DENR-DILG NCI-SRD STRATEGIC COMMUNICATION PLAN FOR FY 2021-2025

WHEREAS, Joint Administrative Order (JAO) No. 1 Series of 2015 stipulates that the Knowledge Management Component Working Group (CD CWG) shall be responsible for developing a common database of information for the national, regional, and provincial convergence initiative; spearhead the development of a monitoring systems of the NCI-SRD; and facilitate the conduct of learning exchange and dissemination;

WHEREAS, the NCI-SRD Alternate National Steering Committee (ANSC), composed of the Undersecretaries of DA, DAR, DENR, and DILG, convened in a regular meeting last 22 October 2019 and approved the DA-DAR-DENR-DILG NCI-SRD Strategic Communication Plan for FY 2021-2025 for official submission to the DA-DAR-DENR-DILG Secretaries;
