



**NCI-SRD RESOLUTION NO 200 Series of 2018**

**APPROVING THE NATIONAL CONVERGENCE INITIATIVE FOR SUSTAINABLE RURAL DEVELOPMENT (NCI-SRD) FY 2019 ANNUAL OPERATIONAL PLAN**

**WHEREAS**, Joint Administrative Order No. 01 Series of 2015 (Strengthening the Implementation Framework for the DA-DAR-DENR-DILG NCI-SRD) identifies the NCI-SRD as a strategy that can contribute to inclusive growth and poverty, particularly in the countryside, through complementation of efforts in the rural sector;

**WHEREAS**, Joint Administrative Order No. 01 Series of 2015 states that through the NCI-SRD, the rural development agencies undertake joint planning, programming and budgeting, as well as monitoring and evaluation in the achievement of the sectoral goals and targets of the Philippine Development Plan 2011-2016;

**WHEREAS**, the NCI SRD National Steering Committee (NSC), composed of the Department Secretaries of DA, DAR, DENR and DILG, issued NCI-SRD Resolution No.1 Series of 2016 last 14 November 2016, adopting the DA-DAR-DENR-DILG JAO No.1 Series of 2015 (Strengthening the Implementation Framework of the NCI-SRD) under the Duterte Administration;

**WHEREAS**, Chapter 8 of the Philippine Development Plan 2017-2022 states that in order to strengthen the efficiency and effectiveness of strategies, the government will continue to pursue the national convergence initiative using the ridge-to-reef approach;

**WHEREAS**, the NCI-SRD Capacity Development (CD), Knowledge Management (KM), Agro-Enterprise Cluster and Agribusiness Development (AECABD) and Policy and Advocacy (PA) Component Working Groups (CWGs) convened last 13 September, 24 September, 25 September and 05 October 2018, respectively and approved their Plans and Activities for FY 2019;

**WHEREAS**, the NCI SRD National Technical Working Group (NTWG), composed of the Chairpersons of the Component Working Groups (CWGs) and Ecosystem Technical Working Groups (ETWGs), convened in a regular meeting last 09 November 2018 and agreed to endorse the NCI-SRD FY 2019 Annual Operational Plan, based on the consolidated plans and activities of the CWGs, NTWG, and the Alternate National Steering Committee (ANSC) to the ANSC;

**WHEREAS**, the NCI SRD ANSC, composed of the Undersecretaries of DA, DAR, DENR, and DILG, convened in a regular meeting last 21 November 2018 and approved the NCI-SRD Annual Operational Plan for FY 2019;

**NOW, THEREFORE**, for and in view of the foregoing, we, the NSC, hereby **RESOLVES** to approve the NCI-SRD FY 2019 Annual Operational Plan.
